

OFFICIAL RULES FOR THE "Roger's Fantasy Picks Podcast"

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

PROMOTION PERIOD: "Roger's Fantasy Picks Podcast" ("Promotion") begins on February 21, 2012, at 12:01 a.m. EST and ends on November 18, 2012 at 11:59 p.m. EST (the "Promotion Period").

HOW TO ENTER: During the Promotion Period, there are two (2) ways to enter: **(1) Online:** Visit <http://www.mispeedway.com/Vanity-Pages/Roger-weekly-pick.aspx> and follow the directions provided to select the driver you think will win the Sprint Cup Series race scheduled for the upcoming weekend and submit to receive one (1) entry into the Promotion. All online entries must be submitted by 5:00 p.m. EST the Friday preceding the event weekend to be eligible. **(2) Via Mail:** Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth, along with the driver you think will win the Sprint Cup Series race scheduled for the upcoming weekend, on a 3" x 5" card and mail the card, with proper postage affixed to "Roger's Fantasy Picks Podcast," 12626 US Hwy 12, Brooklyn, MI 49230. All mail-in entries must be postmarked by the Tuesday immediately preceding the event weekend and received by the Friday immediately preceding the event weekend to be eligible. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household per week regardless of method of entry. Entries received from any person or email address or household in excess of the weekly limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail.
