

OFFICIAL RULES FOR THE “Weekly Renewal Sweepstakes”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: Weekly Renewal Sweepstakes (“Sweepstakes”) begins on September 6, 2019 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on October 18, 2019 at 11:59 p.m. EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are 2 ways to enter: (1) Renew your 2020 NASCAR Cup Series race tickets and/or campsite by mail, phone or website to receive one (1) entry into the Sweepstakes or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: Weekly Renewal Sweepstakes c/o Michigan International Speedway, 12626 U.S. Highway 12, Brooklyn, MI 49230-9068. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor. Released Parties (as defined below) are not responsible for lost, late, garbled, incomplete, delayed, illegible or misdirected entries. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction. Employees of Michigan International Speedway, Inc., (“Sponsor”) its parent, subsidiaries, limited liability and affiliated companies, and advertising and promotion agencies, and each of their respective family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside), and members of their households, whether or not related, are not eligible to enter or win. Sweepstakes is subject to all applicable federal, state and local laws. Void where prohibited by law.
