

OFFICIAL RULES FOR “Michigan International Speedway Trivia”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: Michigan International Speedway Trivia (“Sweepstakes”) at Michigan International Speedway begins on August 20, 2021 at 3:00 PM Eastern Standard Time (“EST”) and ends on August 22, 2021 at 8:00 PM EST.

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: **Participate using the NASCAR® Mobile App:** To participate using the app, each participant must: (a) download the NASCAR® app (the app works on iOS and most android and Windows devices); (b) select “Next Race Guide” in the dropdown menu; (c) select the Trivia banner; (d) play any, some, or all of the categories listed; (e) complete the form upon finishing each category played.

Limit one (1) entry per person, per category. Each participant may complete a maximum of four (4) forms, one for each category completed, earning them four (4) entries into the overall sweepstakes. Entries received from any person in excess of the limitation will be void. All entries become the sole property of Sponsor and will not be returned. Fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, who are of the age of majority or older in the applicable jurisdiction.
